

Though there is rigorous enforcement of laws, in praxis the scenario world over is posed with various challenges and threats because for a larger section of the marginalized society, 'Human Rights'is still an abstract concept be it the conflict zones of Syria or Palestine or the enforcement of draconian laws against homosexuality or an individual being thrashed for being a dalit.

The genesis of the concept of women empowerment is traced within the discourse of gender equality. Empowerment may be related at three levels: individual, societal groups/community, and the interaction between the two. The levels are inextricably intertwined and mutually reinforcing. Women who are emancipated on an individual level will most likely empower or inspire the other level. On the other hand, women strategically essentialized for a common agenda is likely to have positive effect on the individual in the form of a sense of agency.

Over the millennium, the status of women in India has been subject to many changes. In Vedic era, women enjoyed equal status with men. Women sages and seers, notably Gargi & Maitrey, came into prominence. However, the aituation deteriorated with foreign invasion of Mughals. Reformatory movements by Raja Ram Mohan Roy, Pandit Ishwar Chandrs Vidyasagar and positive laws enacted by the British Raj like Abolition of practice of Sati, Widow Remarriage Act did give some relief. The Constitution of India guarantees equality to women (Article 14). Feminist activism gained momentum in India as many groups and NGO's have been working tirelessly for women emancipation.

We are proud that in India women got voting right much before USA or women occupying highest offices of President, Prime Minister, Chief Minister, Lok Sabha Speaker, Chairman of Financial Institution but the ground reality is that we still witness dowry deaths, domestic violence, rapes, molestation, scid attack, daini (witch) killing, child marriage and female foeticide. The urban elite class women have no doubt been benefitted by the efforts of women empowerment, but the women from rural areas and deprived sectors arestill facing deprivation, degradation, dehumanization and death.
